Re: Second Meeting of the Commission, Jakarta, Indonesia

Welcome to Jakarta!

To assist you in planning your stay in Jakarta, I attach a detailed time schedule of the events which will take place in Jakarta from 25 - 31 March. Most of the events scheduled will take place in the Hotel Borobudur, including the Public Hearings and the Commission meetings themselves. A floorplan of the 19th floor (where the meeting rooms are situated) is attached.

As you will note from the schedule of events, some of these are still being finalized, and we shall advise you during the course of the next few days of any arrangements as they affect you.

For any general or secretarial assistance that you might need, we have set up a Secretariat office which is located in room 1827 (tel. 1827) on the 18th floor. Coordination of the Secretariat office will be handled by Mrs Edith Surber, the General Secretariat's Finance and Administration Officer; assisted by Mrs Brita Baker, Secretary to the Secretary General; and Ms Aud Loen, Secretary to the Chairman from the Oslo office. Should you need any information or assistance during your stay in Jakarta, please feel free to contact this office.

As I mentioned in one of my previous memos, the Indonesian Government has kindly agreed to cover all costs of accommodation and meals for Commissioners, and during your stay you should sign all meal receipts. It has been arranged for you simply to sign your overall bill upon your departure. Any telephone charges will, of course, be for your own account.

Please note that we also have a room available for Commissioners to make private telephone calls in room 1825 (also on the 18th floor). Any calls from this room should be made through the hotel switchboard and charged to your room number and account.

Your return flight reservations should be reconfirmed at least 72 hours before departure. Please see Mrs Surber at the Secretariat office so that she may reconfirm your booking.


