

## Update on AfHEA's UHC project: UHC survey completed!

The AfHEA UHC project has the overall aim to build the capacities of African policy makers and young researchers for the development and implementation of health policies and programs towards Universal health coverage. To this end UHC surveys were commissioned in 20

African countries spanning the eastern, southern and western sub regions including Cape vert. Respondents included; policy makers, policy analyst, researchers, Non-Governmental Organization (NGOs) and respective government stakeholders. This survey has been success-

fully completed and analyzed. The results of the survey and policy implications will be discussed at the Joint AfHEA-WHO/AFRO plenary session on UHC and Health Financing in the African Region during the AfHEA conference in Nairobi

# Young Researchers UHC workshop held in Dakar Senegal

A training to address the concerns (for researchers) young with regards to UHC took place in Dakar from Jan 27 - Feb 7. 2014. This was done in collaboration with CE-SAG (Centre Africain d'Etudes Supérieures en Gestion (CESAG). In order to facilitate a

smooth implementation, course curricula was developed by course facilitators. The course was entitled "La couverture universelle en santé: principes de base, mise en œuvre et suivi des progrès".

The training covered 8

countries of francophone Africa and targeted technical service personnel in the Ministries of Health and governmental and quasi-governmental agencies (agencies of social security, health insurance, and health mutual trust) as well as regional institutions involved in universal coverage, researchers, analysts and activists in civil society, etc.

There were 27 participants in the workshop facilitated by 4 high level resource persons.

The success of this course and satisfaction of the participants led to demand for similar training from other Af-HEA partners.

## Redesign of AfHEA website

In order to meet the needs of Français # English the strategic plan, and the ambitions as well as the scope of the association, Af-HEA has redesigned its Home website. It is envisaged that the website shall be used for (i) disseminating the results of research carried out at the global level and relevant literature from African countries with respect to the ob- Welcome to AfHEA website



coverage in Africa, (ii) maintaining the interest of members and affiliates of AfHEA and (iii) improving the Production and Information Management System of AfHEA. The new website shall be bilingual (English and French) and must especially be a vehicle for sensitizing, informing and building the capacity of policy makers and health sector workers, while contributing to policy development processes regarding access to healthcare services, which will be fed in real time through progress in research. Furthermore, the production and information management system of the Association shall be improved.

## AfHEA forms an Advisory board

AfHEA has formed an advisory board in accordance with its strategic plans. The Advisory Board consists of two kinds of people: (i) a cross section of eminent people in international health economics, financing and policy who have contributed significantly to the development of these fields in Africa or who are placed to make such a significant contribution if their skills/ expertise can be tapped, and (ii) representatives of key stakeholders of AfHEA that are not already represented in our elected Board of Trustees, such as partners supporting or sponsoring joint projects with Af-HEA, or eminent University professors in the fields of interest to Af-HEA whose skills would be helpful to fulfilling AfHEA's mandate and mission in Africa.

Members of the advisory board serve in their individual capacity for a fixed term of four years, with the possibility of renewal. The overall function of the advisory board is bring to bear their broad international experience and skills to provide external, independent and sound advice in the areas of health economics, financing and policy to AfHEA, with the objective of helping AfHEA's intellectual work and practices to remain relevant and consistent with the state of the art in the international arena as far as these disciplines are concerned,. The Advisory Board will advise AfHEA on general policy and strategy to achieve its objectives and mission.
