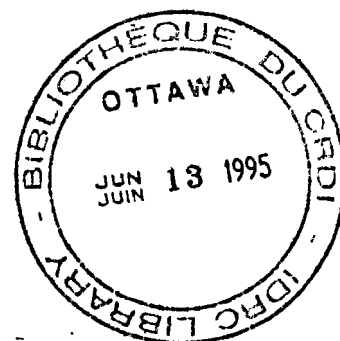

CEUR INSTITUTIONAL SUPPORT GRANT  
3-P-77-0158

In 1977, the Board approved a grant of up to \$ 75,000 for the Centro de Estudios Urbanos y Regionales (CEUR), Argentina, to enable CEUR to continue its research program.

As was explained, The Centro de Estudios Urbanos y Regionales (CEUR), Argentina, was initially associated with different institutions: University of Litoral, University of Buenos Aires, and with the Tarcuato Di Tella Institute. CEUR was forced to seek an autonomous status outside the Di Tella Institute for political and financial reasons. Considering the difficult conditions of social science research in Argentina after 1976, IDRC decided to support CEUR recognizing its important role in the area of urban studies. CEUR was one of the leading groups in the field of urban and regional development, not only in Latin America, but also in the developing world. It also had a very good background in publication-dissemination activities and in providing technical assistance to public bodies in different countries and regions. They also had a post-graduate teaching program in urban and regional development sponsored by CLACSO and ILPES.

CEUR INSTITUTIONAL SUPPORT GRANT  
3-P-80-0215.

This grant for \$ 65,000 to the Centro de Estudios Urbanos y Regionales (CEUR) was approved to enable CEUR to continue to undertake independent research in the areas of urban and regional issues, impact studies and human settlements. CEUR has a long tradition of examining research and policy related questions in urban and rural planning. This short, one year, transitional institutional grant was intended to allow CEUR to stabilize its research activities in the 1981-82 period. Together with the institutional grant, the Centre provided a program grant for the working commission of CLACSO on urban and regional planning. In contributing to this commission, the grant not only guaranteed the continuation of its work at a financially difficult time, but supported initiatives taken by the Centre to encourage researchers to define their own research themes and concerns.

The purpose of this project was to provide an institutional support grant for a period of three years to the Centro de Estudios Urbanos y Regionales (CEUR), Argentina, under the guidelines approved by the Board in March 1981.

CEUR's principal aim was to consolidate the work in their four areas of research, and to ensure an improved administrative structure for the institution. CEUR's plan pointed out that Argentina was changing quickly and that the organization should be responsive to changing circumstances, including the provision of more information to the public on regional and urban issues. The plan dealt in turn with research, human resources, training and the dissemination of materials.

CISEA INSTITUTIONAL SUPPORT GRANT

The purpose of this project was to provide a small independent social science institute in Argentina with an institutional grant for a three year period.

The recipient, the Centro de Investigaciones Sociales sobre el Estado e Administracion (CISEA), has an effective record of research on Latin America and Argentina; an institutional grant thus permitted more flexible funding to continue the activities of the institution. Furthermore, the institutional grant built a viable institutional base with a strong commitment from the staff in difficult circumstances. Thus, the three year institutional grant was aimed at converting CISEA's organizational and research potential into a strong and effective research institution through the provision of stable unattached funding.

The Programa Interdisciplinario de Investigacion en Educacion has made a series of useful contributions to the knowledge of the educational process in Chile. They have explored the short and long-term effects of current educational developments, with special attention to the testing and application of the research findings in the classroom.

PIIE undertook this work with a degree of commitment which has allowed the institution to overcome the difficult circumstances of its existence. One urgent need was to build up a core staff which could rely on long-term funding to complement short-term project support.

PIIE INSTITUTIONAL SUPPORT GRANT

The Programa Interdisciplinario de Investigacion en Educacion (PIIE) was created in 1970 by the Catholic University of Santiago with a grant from the Ford Foundation. After 1973, the change in political regime in Chile has seriously affected the possibilities for conducting research in general and social science research in particular. Many of the social science research faculty in universities and teaching centres have been dismissed and support for social science research in public and private institutions has been withdrawn.

Within this context, the PIIE was another organization in difficult circumstances in 1977. PIIE's first director was Ernesto Schiefelbein, one of the most highly regarded educational researchers of Latin America. Under his leadership, PIIE became a leading institution in its field in Latin America. PIIE was attached to the Academic Vice-Rectorate of the University until June 1977 when it was asked to dissolve itself. Since that time the group has continued its work as an independent institution under the wing of the Academia de Humanismo. Considering these circumstances, this IDRC grant (\$ 75,000) was intended to enable PIIE to continue its research program.

The Facultad Latinoamericana de Ciencias Sociales (FLACSO) is a regional organisation with centres in Argentina, Chile, Ecuador, Costa Rica, and Mexico. Each centre conducts research and training in social sciences, in general concerning the regional problems of development, but without ignoring significant differences among the countries involved. The Santiago office of FLACSO was created in 1957, and until 1973 was the only regional centre in existence. Despite the unfavourable circumstances of the Santiago office after the military coup in 1973, FLACSO continued to undertake a significant number of research and training activities. Since 1973, the office has played a highly important and visible role in ensuring the continuity and progress of the social sciences in Chile. On July 11, 1979, the Chilean government withdrew from the intergovernmental agreement which gave both Chilean support and legal status to FLACSO's Chilean operation.

The purpose of the IDRC grant was to meet operating and institutional costs during the crucial transition year of 1980. The 1980 research and training programme of FLACSO's Santiago office indicated its crucial involvement in the continued development of Chile and of the region. The IDRC grant, therefore, was utilised during a crucial period in FLACSO's history. It was intended to ensure over a one-year period the viability of local administrative and support operations, and in turn, to enhance the ability of FLACSO to maintain an independent and respected tradition of social sciences research in Chile.

In the three years 1979-82, during which the Social Sciences Division supported FLACSO, the work of this institution has increased in methodological sophistication and there was a valuable rethinking of some basic social science tenets. These refreshing developments influenced research work in both Chile and Latin America.

FLACSO's ambitious three year indicative plan of 1982-85, was a direct result of the assistance afforded by the Centre and other agencies since 1980. The Centre provided two transitional institutional grants of one year's duration each which was to permit them to stabilize the institution under difficult and uncertain conditions. From this support, it was concluded that both the research management and the effectiveness of the institution have greatly improved, and that a long-term grant, under the guidelines established by the board, would be beneficial to the institution and to the promotion of alternative development perspectives in Chile.

This institutional grant was intended to allow FLACSO to fulfill its research potential and further improve its research effectiveness.

After the 1973-75 period, when the University cut research funding, a group of economists decided to form an independent group which would allow competent professionals to remain in Chile and carry on policy-relevant research.

In this context, the Executive Committee of IDRC authorized, in June 1977, a grant of \$ 150,000 over a period of 45 months to Centro de Estudios de Estado y Sociedad (CEDES) in Buenos Aires, and to Corporacion de Investigaciones Economicas para Latinoamerica (CIEPLAN) in Chile. The Grupo de Investigaciones Agrarias (GIA) undertakes research and diffusion activities on the social and economic aspects of Chilean agriculture and rural life. Since 1973, smallholders and peasants have received little support from the state. The technical advice and extension work has been supplied by a series of non-governmental organizations (NGOs) often backed by the Church, which have been working under difficult circumstances and with limited resources. The GIA has been instrumental in linking the NGOs and showing the value of research for action and planning. For example, the organization of two/three day meetings (jornadas) became a useful forum in which campesino leaders, extension workers, researchers and technical advisors met. In this way, GIA was playing a very important role in supplying assistance to this sector.

The purpose of this project was to support with a special institutional support grant a number of activities which strengthened the research capacity and assisted in the dissemination process of the Grupo de Investigaciones Agrarias GIA.

In 1973, Uruguay's Congress was dissolved and a period of military governments started. With the military intervention of the University in 1973, the Institute of Social Sciences was rapidly disbanded and its staff replaced. The director of the Institute of Social Sciences, Carlos Figueroa, decided to organize a new research institute which later became the Centro de Informaciones y Estudios del Uruguay (CIESU). The first institutional support was given in 1975 by The Ford Foundation, and IDRC support for CIESU commenced in 1976 with a project on the graphics industry.

Prior to the coup, the relationship between social scientists and the government was that of close collaboration; in particular, the development theories of CEPAL had had considerable impact. At the moment of the coup, there was only one private research centre of significance, *Economía Humana*, tied to the Catholic Church. After the coup in 1973, this institution assumed a stronger role, given the disappearance of social science research activity within the university and the government.

CIESU was founded in 1974. The first years were heavily dependent on the personal resources of the researchers and outside funding. CIESU as a research institute defined its role particularly as being concerned with keeping open social science research in Uruguay. Since the beginning of the 1980s, CIESU was probably the single institution in Uruguay with the capacity to maintain a tradition of competent, empirically based, pluralistic work in the non-economic social sciences.

The Centro de Informaciones y Estudios del Uruguay (CIESU) undertakes research on social, economic, and political problems in Uruguay. CIESU has experienced financial and operating difficulties because of the lack of financial support. The purpose of this project was to provide a three year institutional support grant to CIESU under the guidelines approved by the Board in March 1981.

CIESU was founded in 1975 as a private research institution by a group of professional social scientists who had been dismissed from the University when the military government eliminated the Instituto de Ciencias Sociales and excluded the social sciences from the university curriculum.

In 1981, CIESU moved to a larger office than its previous location and established a library and documentation centre. CIESU's first research projects were in the area of demographic studies. By the late 1970s, more sophisticated work in demography was being undertaken, but research interests had also expanded to include studies on the condition of rural population, on the country's public housing policy, and on the health care system. CIESU was also involved with an industrial association and a private rural development agency in joint studies on technical change in the printing industry, on the role of small farmers in domestic food production, and on the impact of government policy on social conditions.

The University of Guyana, of which the Institute of Development Studies (IDS) is a constituent part, receives its income from public funds. Guyana's economic and fiscal crisis at the beginning of the 1980s forced the government to cut expenditures and its support for primary, secondary and higher education. The general objective of this institutional grant was to provide funds for equipment and research in order to allow the Institute of Development Studies to continue research and to maintain its research capacity.

It seems that no country in the Caribbean has suffered from professional emigration more than Guyana. In 1982, as the University entered a new phase of deprivation, it was important to provide the facilities which could try to encourage researchers to stay in Guyana to do research in relevant areas for national and regional policy. Guyana, first because of policy, and later as a result of the economic situation, was more and more cut off from other Caribbean research and educational developments.

The objective of this proposal was to support the creation of a network among a number of social science institutions in the Southern Cone of Latin America in order to permit them to pool resources and to further the quality of research training programs.

Between 1973 and 1983 a number of independent research centres in the Southern Cone made an important contribution to a greater understanding of the structure and process of economic, political and social change of these countries. The majority of the independent research centres emerged as a response to government actions. First, these countries --Paraguay, Uruguay, Argentina, Chile-- have been ruled by military governments since 1973/76. Official policy has been to discourage social commentary, criticism and research. Second, the governments have controlled the majority of universities by appointing officials, re-organizing curricula and limiting access to university education. Third, universities discouraged research in most subjects and, in the case of social sciences, restricted graduate study severely.

The majority of the private research centres were established --often by teachers who had been dismissed or voluntarily retired from the universities-- in order to continue independent research. Through this grant of a \$ 134,200, the Centre intended to support the creation of a network among a number of social science institutions in order to permit them to pool resources and to further the quality of research training programs.

The Latin American Council for Social Sciences (CLACSO) is the major social science umbrella organization of Latin America. It is an international non-governmental organization (with class B consultative status with UNESCO), indigenous to the region and deriving full support for its secretariat from member organizations. In 1978, it had approximately one hundred and twenty member institutions which included many of the outstanding social science research organizations in Central and South America. CLACSO has achieved an international recognition for its policy relevant research support and training activities.

CLACSO's objective is to strengthen social science research and training in Latin America. This goal is pursued through a number of regional programs which emphasize the value of mutual co-operation and support between participating institutions. The principal programs are: a) working groups on social issues such as poverty in Latin America, urban development or conditions of work; b) research awards for junior and senior researchers; c) special research awards for scholars or researchers who face persecution or other difficulties because of their work; d) the promotion of post-graduate studies in Latin America; and, e) the dissemination of research results between member institutions, the public and governments.

During the 1970s and 1980s, CLACSO has played an important role in linking researchers from different parts of the continent and has encouraged social scientists to involve themselves in the professional development of their subjects and to participate actively in the development process. CLACSO has also helped to defend social scientists whose life or livelihood are threatened, and it is also a useful conduit for information and research activities with other parts of the Third World. IDRC's support for CLACSO has emphasized the awards programs while strengthening a number of associated activities, all of which helped CLACSO to accomplish its mission more fully in the period 1978-87.



CLACSO's achievement can be measured by its ability to co-ordinate and organize research work regionally. The Consejo has attempted to provide a focus for collaborative work by establishing a number of programs. The most important were: the joint working groups; Latin American postgraduate training and teaching; the research awards and the dissemination of research results in both Latin America and the Caribbean. The programs were built on the premise that problems of social analysis, structure and change in developing countries are most fruitfully explored by comparative approaches, and that institutions and scholars in the region have a great deal to learn from one another.

As an institution, CLACSO was, between 1978 and 1987, one of the most generously supported recipients of IDRC social sciences funding:

In 1987, CLACSO presented a proposal to IDRC which was essentially a small-grants activity. The Social Sciences Division decided not to fund this proposal. In fact, by giving research funds to CLACSO, there was the possibility of introducing certain involuntary distortion in the development of research institutions in the region (as opposed to the natural way in which the projects are developed directly between IDRC and the research centres). CLACSO was not set up to carry out research (unless one refers to the research that is carried out through its member research centres), but to develop the promotional and support activities described above, and along these lines, CLACSO has played a very important role in the region.

The overall activities of CLACSO during the 1978-87 period of IDRC support were very positive for the promotion of research in Latin America. The Young Researchers Program and the information activities have been particularly important. CLACSO has the only program in the region aimed at a practical training of young researchers which is one of its most important programs, given the fact that it gives young researchers an opportunity to actually get engaged in research. But the main role that CLACSO has played has been one of providing a regional framework which has facilitated

- a) a regional dialogue and exchange of experiences among research centres;
- b) the dissemination of results and the comparative analysis of research results; and
- c) the collective regional research efforts through regional networks on specific research topics.

The principal objectives of this programme, and thus of this project of support from IDRC were:

- a) to resolve "critical situations" faced by social scientists in Latin America. A critical situation is defined as one where "political reasons prevent a social scientist from practising his profession in his country of origin or residence, whether in government institutions, in private bodies or on his own. The measures which constitute such a situation may take the form of dismissal, the barring of access to a workplace, arrest, exile, and other forms of discrimination which prevent the social scientist from practising his profession."
- b) To prevent the emigration of Latin American social scientists, and particularly emigration to centres in Europe, the U.S. and Canada.
- c) To encourage the repatriation of Latin American students who have continued and completed their studies outside of Latin America, and of Latin American researchers who are presently working abroad.
- d) To build up the CLACSO member centres by increasing their overall capacity to carry out research projects; train new social scientists, and disseminate information.

In addition, the Centre's grant funds had the particular goal to place young and middle level researchers in research positions and projects.

CLACSO met the most important objectives of the grant, particularly a), b) and d). It has maintained scholars in Latin America in increasingly difficult circumstances and strengthened the indigenous research capability of the region. In 1980, it requested that an outside evaluation team consisting of researchers from the Universidad del Pacifico (Lima), FLACSO and Yale reviewed their program. They confirmed that the program was well run and that the research had maintained a high standard and that in most cases support had meant the difference between a person undertaking research, finding another job or leaving the country. However, they indicated that the research grants

were small; that senior and junior recipients should be divided into separate competitions; and, that a fund should be established to support the publication of some of the research findings.

The first objective, the special award program for persecuted scholars, was in considerable demand between 1981-83 and after the period of the grant. The program provided 46 awards (1981-83) with a total of \$ US 134,100. This program was supported by SAREC and IDRC who contributed \$ US 47,000 and \$ US 26,000 respectively in 1983 for a total of 28 research awards. The award holders were nationals of Argentina (8), Bolivia (7), Chile (2), Uruguay (4) and the Central American region (7).

The second objective was also achieved very well. In 1982, CLACSO awarded 14 junior research awards and increased the total in 1983 to 23 awards with a total disbursement for junior research awards of \$ US 72,480 which was financed with resources from IDRC, SAREC and the UNDP. The Centre's support amounted to \$ US 39,000 or 54 percent of the total.
