Points to highlight on 1325/the presentation

We're gathering today to celebrate the seventh anniversary of United Nations Security Council Resolution 1325 on Women, Peace and Security, an event co-sponsored by the Gender and Peacebuilding Working Group of the Canadian Peacebuilding Coordinating Committee and by Peace, Conflict and Development, here at IDRC.

Cependant, elle affirme également le rôle important des femmes dans la prévention et la résolution des conflits et dans la consolidation de la paix.

To highlight this last point, we are also launching the book *Women Building Peace Between India and Pakistan*, edited by Shree Mulay and Jackie Kirk, who will present later. This book emerged from a workshop on the topic that was sponsored by IDRC's Peace, Conflict and Development program; the Gender and Peacebuilding Working Group of the Canadian Peacebuilding Coordinating Committee and Peace; CIDA, the Canadian Consortium on Human Security; and McGill University.

On Senator Mobina Jaffer

Since her appointment to the Senate of Canada in 2001, Senator Mobina Jaffer has been a strong voice in the struggle to end violence against all women. She is a member of several Senate committees, including as Deputy Chair of the Human Rights Committee. As well, Senator Jaffer served as Canada's Special Envoy to the Peace Process in Sudan from 2002 to 2006.
