# **1. WHAT IS EEPSEA?**

The Economy and Environment Program for Southeast Asia was established in May 1993 to support training and research in environmental and resource economics. Its goal is to strengthen local capacity for the economic analysis of environmental problems so that researchers can provide sound advice to policymakers. The program uses a networking approach to provide not only financial support but meetings, resource persons, access to literature, publication outlets, and opportunities for comparative research across its ten member countries. These are Thailand, Malaysia, Indonesia, the Philippines, Vietnam, Cambodia, Laos, China, Papua New Guinea and Sri Lanka.

EEPSEA's structure consists of a Sponsors Group, comprising all donors contributing at least USD 100,000 per year; an Advisory Committee of senior scholars and policy makers; and a small Secretariat in Singapore and the Philippines. EEPSEA is a project administered by the International Development Research Centre of Canada (IDRC) on behalf of the Sponsors Group. (IDRC is a public corporation created in 1970 to support research in developing countries.)

Typically, researchers learn about EEPSEA by various means and apply for a research or training award. Most applicants attend one of EEPSEA's courses before or in conjunction with their research project. Budget ceilings for research projects are USD 15,000-22,000, depending on the country, exclusive of a small honorarium. Researchers may be affiliated with a university, government or non-government organization and grants are normally made to that institution. Most projects are carried out by teams of researchers.

Proposals are sent to experts for written review. Those recommended for further consideration must then be revised and presented in a working group meeting at the next EEPSEA biannual meeting. Further revisions are usually called for, until the project is judged satisfactory and a grant approved. After approval, interim findings are presented and critiqued every six months until the project is completed. Researchers receive frequent technical assistance and literature from the Secretariat and resource persons. Final reports from successful projects are widely disseminated by EEPSEA and by the researchers themselves through publications, the media, and consultations with policy makers.

The selection process for both training and research awards is highly competitive. Of 130 applications for our 1997 course, 27 were accepted. Approximately one application in three for research awards is accepted. To date, EEPSEA has provided training to some 150 people and supported about 65 research projects.

# 2. CONTEXT AND HIGHLIGHTS

Key features of the region's research environment that condition EEPSEA's approach to capacity building include extreme diversity across countries with respect to income levels, population and research capacity; rapid change in economic growth and infrastructure; the high profile accorded mainstream economics; and a relatively strong research infrastructure in many countries.

July 1998 marked one full year of economic turbulence as currencies and stock markets in most ASEAN countries plummeted. What began as financial crisis had spread to the "real" economy by early 1998 and many countries experienced recessions and the highest rates of unemployment in fifteen years. Effects on the environment are likely to be significant, though difficult to identify with confidence; these may be negative, positive or ambiguous. Public and private budgets for pollution control appear to be shrinking; on the other hand, financing for mega-projects with dubious environmental impacts (e.g. some large dams and road-building projects) is also reduced. Urban unemployment may increase migration to rural areas and intensify resource exploitation. Currency devaluation will also shift the composition of imports and exports, with effects that are difficult to foresee.

The other dramatic event that affected the region in 97/98 was Indonesia's forest fires, which resulted in the burning in of some 5 million hectares of land. The resulting smoke blanketed the region, affecting some 70 million people, in one of the worst environmental disasters of the century. EEPSEA was an important actor in the response to the fires, working with the World Wide Fund for Nature to estimate the economic cost of the haze and fire, and bringing these results to the attention of senior government officials, NGOs and the media. (More than 100 media citations of the EEPSEA/WWF study were recorded.)

As EEPSEA's exposure grows and the WorldWideWeb becomes increasingly accessible, EEPSEA has attracted more applications from SE Asians in overseas PhD programs. The number of thesis awards increased noticeably and included two awards to Papua New Guineans. EEPSEA now has activities in all ten member countries. Following the publication of EEPSEA's first Research Report in 1997, eight others were published in 97/98. These highlights and other activities are described in more detail in subsequent sections.

## **3. TRAINING**

EEPSEA explored a wide range of training options in its first four years, beginning with a five-week course at the Harvard Institute for International Development and including others as they become available. These included short courses in Sweden and Australia; a correspondence course from Wye College in UK; a two-year MSc at York in UK; and postdoctoral fellowships in Canada.

In 1997, the overseas short courses were de-emphasized as EEPSEA organized more of its own courses. A new addition in June 1997, and the centerpiece of EEPSEA's training program, was the five-week course in Los Banos, Philippines. This was offered for the second time in June 1998.

#### a) Regional Short Course in Los Banos

A regional short course had been planned since EEPSEA's inception and was deferred, primarily because of the amount of work required to design and administer it. With the hiring of a part-time Deputy Director in May 1996, this constraint was reduced. The course was offered for the first time in June 1997 in Los Banos, Philippines and repeated in 1998.

This five-week course in environmental and resource economics took place at the Southeast Asian Regional Centre for Graduate Studies in Agriculture (SEARCA) in Los Banos, Philippines. In 1998, it included a cash contribution of about USD 75,000 from EDI. Some of this was for a module on the effects of economy-wide policies on the environment. with EEPSEA researchers and EDI-affiliated senior government officials.

The course was announced in October 1997. 91 applications were received from EEPSEA member countries, of which 27 were accepted.

The curriculum was adapted from EEPSEA's five-week course in Vietnam; the curricula of overseas short courses; EDI curricula; and content provided by the instructors. The course concluded with a three-day session on proposal preparation, in which participants designed research projects for submission to EEPSEA.

An MSc in economics was the minimum qualification for the course. However, to accommodate participants without this qualification, EEPSEA offered a four-week preparatory course on essentials of economics prior to the five-week environmental economics course. This was taught by faculty of the University of the Philippines at Los Banos. Ten applicants to the environmental economics course were enrolled in the preparatory course. Of these, four passed and went onto the five week-course.

The students were tested each week. The grades were used to provide feedback on the level of difficulty of the course and to assess graduates' suitability for future work with EEPSEA.

## 4. RESEARCH

Proposals continue to be received on a wide range of topics, including water; policies for control of urban pollution; and environmental impacts of agriculture. There is also growing interest in trade & environment and computable general equilibrium modelling of economy & environment linkages.

# 5. SPECIAL REPORT ON FIRE & HAZE DAMAGE

Between October 1997 and May 1998, EEPSEA collaborated with the World Wide Fund for Nature on a study of the **economic value of damages from the 1997 fires & haze in Indonesia**. Results were presented to a 1998 meeting of ASEAN Environment Ministers, as input to the formulation of a regional haze action plan. The findings were also discussed as the first agenda item in a Meeting of the UN General Assembly Committee on Humanitarian & Social Affairs, chaired by the Undersecretary General of the UN on June 2. Close to 100 media citations have been recorded, including Financial Times, BBC, CNN, Globe & Mail, Washington Post and International Herald Tribune (see Annex 1 for a complete list). After the report was submitted to the ASEAN Environment Ministers meeting in February, Singapore's Minister said the following:

"Asked how much help [in dealing with Indonesia's 1998 fires] Singapore could provide with a planned tight budget for this year, he said: 'Even with a tight budget, we have to prioritize because if we do not help them, the economic losses to us and the entire region are tremendous... Whatever we can spend to help will be money well spent." (Straits Times, Feb. 26/98).

The resulting interviews and inquiries from the media has secondary benefit: they served to expand EEPSEA's contacts with the media enormously, so that we are now part of their roster of experts, frequently called on to comment on the fires and other environmental issues.

The final report is scheduled for publication as a book in early 1999. A summary of the study can be viewed at the EEPSEA Website.

## 6. WORKSHOPS

Every six months EEPSEA holds workshops in Singapore, during which new proposals, reports on work in progress, and talks by international resource persons are presented and discussed. These biannual workshops were held November 19-22, 1997 and May 12-15, 1998 and were attended by about fifty participants. Workshops now include sessions on Day 1 and Day 3 in which researchers spend 1-3 hours with the resource persons assigned to their projects to prepare their presentations and to review comments made during the workshop and clarify what revisions are needed. The format for the formal sessions remains unchanged, with about half the time devoted to plenary sessions and half to working groups. Plenary talks by international resource persons are include "how to do it" presentations of methodology, based on personal experience; emerging

themes and policy issues; and case studies of practical applications. The range of resource persons attending the meetings is increasing and includes more experts from the region and nearby (e.g. Taiwan, Hong Kong and Australia).

EEPSEA's ninth biannual workshop in November 1997 was the largest so far, with over sixty people in attendance. Associated meetings were held with ASEAN, World Bank-EDI, WWF, and the Environmental Economics Network for Latin America and the Caribbean. (The Director of the Environmental Economics Network for East & Southern Africa attended the May 1998 workshop.) Plenary talks dealt with climate change negotiations, the SE Asian haze of 1997, the effects of the financial crisis on the environment, and other topics.

# 7. DISSEMINATION & IMPACT

EEPSEA projects in China and the Philippines were featured in a series of educational videos called "Preserving the Legacy". The videos are designed for university audiences and deal with environmental protection.

## c) Other Publications & Events

Two textbooks on environmental economics in local languages have been published or are in preparation. Published in Chinese is a textbook by EEPSEA researcher Fan Zhang; in preparation is a textbook in Thai by EEPSEA researcher Churai Tapvong and associates. Both draw heavily on EEPSEA materials.

Reports from three EEPSEA-sponsored projects were presented at the international conference of the Western Economics Association in Bangkok in January. Six EEPSEA researchers presented their work at a conference on East Asian Environmental and Resource Economics and Policy in Taiwan in March. Two EEPSEA researchers presented their work at the inaugural meeting of the Philippine Association of Environmental and Resource Economists in January.

EEPSEA resource person Jack Ruitenbeek presented a lecture on valuation methods at the Centre for Ecological Economics, Chulalongkorn University, Thailand. This activity, co-financed with Chulalongkorn, was one of several which inaugurated the Centre's Masters program in ecological economics.

The Philippine Association of Environmental and Resource Economists held its inaugural meeting, with EEPSEA support, in January.

A report summarizing EEPSEA's first five years was prepared. The document, in an attractive format, will be published in October 1998.

The site received about 60,000 "hits" or visits in 97/98. This is about 5,000 hits per month, compared to 1,450 per month in 96/97. As of June 1998, hits were running at over 8,000 per month.

# 8. NETWORKING AND COLLABORATION

EEPSEA continues to play an important role as an information clearing house and resource base for the region. A major expansion of the outreach program was undertaken in 1996, including expansion of the Website and mailing list. These need to be continuously maintained, improved and updated. Efforts have begun to facilitate the formation of national environmental economics associations, which can serve as a link with EEPSEA's regional program.

Collaboration with other organizations active in environmental economics continues. Agencies with which EEPSEA is in frequent contact include World Bank, EDI, IIED, the University of Goteborg, the Beijer Institute, ADB (particularly its APREETA training program in extended cost-benefit analysis), the EENESA and EENLAC environmental economics networks in Africa and Latin America; and the AERC macroeconomics network in Africa.

#### 9. MANAGEMENT

#### a) Secretariat

David Glover (Director) and Catherine Ndiaye (Program Assistant) continued as full-time employees of the Secretariat. Herminia Francisco (Deputy Director) reduced her time commitment from 80% to 60% to allow more time for teaching at the University of the Philippines, Los Banos. Jariah Saad joined the Secretariat as Secretary, 20% time.

#### **b)** Advisory Committee

Jeremy Warford and Marian de los Angeles completed their terms and left the Committee, while Ma Zhong of Renmin University, China joined.

#### c) Sponsors Group

The Group held its annual meeting in Singapore in May 1998 to review and approve the Annual Program of Work & Budget. The Department for International Development, UK (formerly Overseas Development Authority) left the Sponsors Group following a re-ordering of the agency's priorities.
